2. **Explicitly Request Cash:** If you are legally owed a refund, state clearly that you want it returned to your **original form of payment** rather than accepting a travel voucher, .

- **Credit Card Chargeback:** Contact your bank to dispute the charge under "**services not rendered**",,.
